家事移工
因工作受傷無法工作

雇主不能擅自扣薪，須按照雙方簽訂勞動契約執行

นายจ้างต้องจ่ายเงินเดือนให้แรงงานต่างชาติตามจำนวนที่เคยได้รับห้ามหักเงินเดือนโดยผลการหรือให้แรงงานต่างชาติรับผิดชอบค่าเสียหาย

(ตามกฎหมายประกันภัยแรงงานหรือกฎหมายอื่น หากนายจ้างได้ชำระค่าใช้จ่ายแทนแรงงานต่างชาติแล้วสามารถนำเงินค่าใช้จ่ายส่วนนั้นมาหักลบจากเงินทดแทนที่ต้องจ่ายให้แรงงานต่างชาติได้)

ผู้ช่วยงานบ้าน

ห้ามนายจ้างหักเงินเดือนโดยผลการ ต้องปฏิบัติตามข้อกำหนดในสัญญาจ้างที่หั้งสองฝ่ายลงนามร่วมกัน

In the event of a workplace **injury** employers cannot unilaterally make deductions from your salary

Foreign workers Unable to work after a workplace injury

Employers are required to compensate workers based on their original salary. No unilateral deductions can be made from salaries and the foreign worker cannot be asked to take responsibility for losses. (However, in accordance with the Labor Insurance Act and other legal provisions, if the employer pays related costs and compensation they can be offset against salary compensation).

Live-in foreign workers Unable to work after a workplace injury

Employers cannot make unilateral deductions from salaries and must adhere to provisions agreed by both parties in the labor contract.

Không thể làm việc do **bị thương** khi làm việc

Người sử dụng lao động không được phép trừ lương



Lao động nhập cư không thể làm việc do chấn thương khi làm việc

Người sử dụng lao động phải bồi thường cho người lao động nhập cư dựa trên mức lương ban đầu, và không được tự ý khấu trừ lương hoặc yêu cầu người lao động phải tự chịu tổn thất.

(Tuy nhiên, nếu cùng một tai nạn, người sử dụng lao động đã bồi thường theo quy định của điều lệ bảo hiểm lao động hoặc pháp luật khác, khoản phí này có thể được sử dụng để bù đắp vào tiền lương).

Giúp việc hoặc khán hộ công gia đình không thể làm việc do chấn thương khi làm việc

Người sử dụng lao động không được tự ý khấu trừ tiền lương, phải thực hiện đúng hợp đồng lao động mà hai bên đã ký kết.

Nếu gặp trường hợp này, bạn có thể gọi tới đường dây nóng 1955 để được tư vấn hoặc khiếu nại, nhằm bảo vệ quyền lợi của mình.

Công ty môi giới Á Thái quan tâm bạn

Tidak Dapat Bekerja Karena Cedera Kerja Pemberi Kerja Tidak Boleh Sembarangan Memotong Gaji

Pekerja Migran Tidak dapat bekerja karena cedera kerja

Pemberi kerja harus memberikan kompensasi berdasarkan upah asli kepada pekerja migran, dan tidak boleh sembarangan memotong gaji atau meminta pekerja migran sendiri menanggung kerugiannya

(tetapi untuk kasus kecelakaan kerja yang sama, berdasarkan Undang-Undang Asuransi Tenaga Kerja atau undang-undang lainnya, jika pemberi kerja telah membayar biaya kompensasi maka biaya tersebut dapat dipotong dari kompensasi gaji yang harus dibayarkan kepada pekerja migran bersangkutan)

Pekerja Migran Sektor Rumah Tangga Tidak dapat bekerja karena cedera kerja

Pemberi kerja tidak dapat memotong gaji tanpa persetujuan, harus berdasarkan perjanjian kontrak kerja yang ditandatangani kedua belah pihak

Jika Anda menemui situasi seperti ini, dapat menghubungi Saluran Khusus 1955 untuk konsultasi atau pengaduan, guna menjamin hak Anda.
